The placement shall be subject to the final outcome of writ petition(s) pending, if any, in Hon'ble Court of Law.

4. The placement is subject to confirmation by the Departmental Promotion Committee.

5. The placement is subject to the clearance and acceptance of service records/details submitted in the prescribed J&K HRMS Portal at their concerned DDO.

6. The concerned DDO(s) shall ensure that the appointment orders in respect of the officials have been issued by competent authority in terms of the norms issued by Government from time to time before entering the necessary promotion entries in their Service Records.

7. The official(s) shall continue to work at their present place of postings till proper arrangement

is made.
