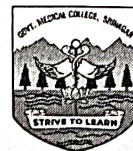

As recommended by Establishment committee in its meeting held on 04-12-2024, without prejudice to the seniority of others and subject to the confirmation by Departmental Promotion Committee, sanction is hereby accorded to the placement of below mentioned officials in Sterilization (CSSD) Unit temporarily on Stop Gap Arrangement basis as **I/c CSSD Technician/CSSD Supervisor in the Pay Level-6D (35800-113200)** in their own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled up by the Competent Authority/DPC whichever is earlier.

**The above placement is subject to the following terms and conditions:**

1. The placement is temporary and shall not confer any preferential right on the officials to hold the posts on substantive basis or claim promotion which shall be made in accordance with the rules.
2. The placement is purely on Stop Gap Arrangement Basis for a period of six months or till the posts are filled up by the competent authority/DPC whichever is earlier.
3. The placement shall be subject to the final outcome of writ petition(s) pending, if any, in Hon'ble Court of Law.
4. The placement is subject to confirmation by the Departmental Promotion Committee.
5. The placement is subject to the clearance and acceptance of service records/details submitted in the prescribed J&K HRMS Portal at their concerned DDO.
6. The concerned DDO(s) shall ensure that the appointment orders in respect of the officials have been issued by competent authority in terms of the norms issued by Government from time to time before entering the necessary promotion entries in their Service Records.
7. The official(s) shall continue to work at their present place of postings till proper arrangement is made.
