

- The concerned DDO shall ensure that initial appointment of the official is genuine and the appointment order in respect of the promotee has been issued by competent authority in terms of the norms issued by Government from time to time.
- The claim of the senior(s) if any received within the stipulated time, shall be evaluated as per governing norms and if found necessary, the senior incumbent shall be placed in OPG/ promoted at proper place by demoting the junior most one(s) an ab-initio without giving any notice.
- The official shall continue to work at his present place of posting till further orders.
