Pursuant to the authorization/approval and relaxation in Qualification Bar conveyed by Administrative Department (HME) vide letter No. ME-NG/181/2022-02(197513) Dated:-10-06-2024 and after receipt of satisfactory character & antecedants verification report received from Criminal Investigation Department vide No.110714 Dated: 26-11-2024, sanction is hereby accorded to the temporary appointment of Ms. Nadiya Bilal W/o Late Bilal Ahmad Sheikh (Ex-Sweeper) R/o Danpora Brain Tehsil Khanyar District Srinagar A/P Sheikh Mohalla Pandrethan Panthachowk Srinagar as "Sanitation Worker(Class-IV)" in the pay level SL-1(14800-47100) against the available vacancy in Govt. Medical College and its Associated Hospitals, Srinagar in terms of Jammu & Kashmir (Compassionate Appointment) Rules, 1994, notified vide SRO-43 of 1994.

The appointment order shall be further subject to the following terms and conditions:-

- 1. The appointee shall submit her joining report to the office of the Principal/Dean, Govt. Medical College, Srinagar within a period of **twenty one (21) days** from the date of issuance of this order; failing which she shall forego her right to appointment and the same shall be deemed to have been cancelled *ab-initio* without any further notice.
- 2. The appointee shall be allowed to join only on the production of following certificates (In original) to be verified subsequently:
 - a. Date of Birth certificate.
 - b. Domicile certificate.
 - c. Current Marital Status (Certificate issued by competent authority).
 - d. Medical Fitness certificate from Chief Medical Officer (CMO) concerned.
 - e. Dependent Certificate issued by the Assistant Commisioner Revenue (concerned).
 - f. No Objection Certificate (NOC) from District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District. If the candidate has taken loan for self employment from DIC/Employment Department, he/she shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self employment unit/ enterprise before joining the Government service. He/she shall be required to repay the entire liability in suitable EMI's to be worked out by the DDO concerned from his/her salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit enterprise and recovery to be made and also personally monitor its recovery.

- 3. The salary of the appointee shall not be drawn and disbursed to her unless and until, satisfactory reports in respect of genuineness of Date of Birth/Domicile Certificate/Dependant Certificate/relevant category certificate (if any), is received from the concerned authorities/agency.
- 4. The appointee shall give an undertaking in the shape of an affidavit duly attested by Ist Class Judicial Magistrate to the effect that if on verification, her Date of Birth/Domicile Certificate/Dependant Certificate/ Reserved Category Certificates (if any) from the concerned issuing authorities are found fake/forged, her appointment as "Sanitation Worker(Class-IV)" in Govt. Medical College and Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated aganist her. She in that case shall not claim for any dues from Govt. Medical College and its Associated Hospitals, Srinagar.
- 5. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 Dated: 24.12.2009.
 - 6. The incumbent shall be on probation for a period of two (02) years.
- 7. The appointment in Divisional Cadre is non transferable from one Division to another or from one Medical College to another.
- 8. The appointment of the incumbent shall be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
