- That, the above arrangement is subject to the final outcome of the writ petition(s) pending before Hon'ble Court of Competent Jurisdiction or departmental proceedings pending against any official, if any or any order already passed, but not brought into the notice of Establishment Committee.
- That, the above arrangement is further subject to the clearance and acceptance of the service details/records submitted in the prescribed J&K Human Resource Management System (HRMS) portal.
- That, the concerned DDO shall ensure that the appointment orders in respect of the above official has been issued by competent authority in terms of the norms issued by Government from time to time before entertaining the necessary promotion entries in the service records of the respective official.
- That the placement is subject to the amendment and rectification of the recruitment rules from the Administrative Department during the course of finalization process of recruitment rules.
