That in case any adverse report regarding genuineness of Qualification, Date of Birth, Marks certificates, Domicile Certificate etc, if any, is received from the competent authority to whom the references shall be made by the concerned DDO, the candidate shall have no right to claim her engagement as Tutor/ Clinical Instructor & her engagement as such shall deem to have been cancelled ab-initio and she will lose the right to claim for any dues from Govt. Medical College, Srinagar and shall be liable for any lawful action.
