Subject: Promotion of Phase II MBBS (Batch 2022) to the Phase III Part-I MBBS.

Whereas, Mr. Aaqib Ali Khan was allotted MBBS Seat in Government Medical College, Srinagar through J&K BOPEE and accordingly joined Phase I MBBS Batch 2022 on 28-11-2022; and

Whereas, the said student was ineligible to appear in Phase I MBBS (Regular Examination – Session November 2023) with his own Batch 2022 due to shortage of attendance, which was scheduled from 04/11/2023 by the University of Kashmir vide No. F (Date Sheet-MBBS 1st Year/KU/2023) dated 27/10/2023; and

Whereas, he appeared in Phase I MBBS (Supplementary Examination – Session Jan-Feb 2024) with his own Batch 2022 scheduled from 23/01/2024 by the University of Kashmir, and was declared **Fail** in one subject (Physiology) vide Notification No. 1st (Supplementary) Examination of Jan-Feb 2024 dated 07/03/2024; and

Whereas, in terms of the Advisory issued by the National Medical Commission (NMC) vide No. NMC/Advisory(MBBS)/2021/029415 dated 21/10/2021 and the Competency Based Medical Education (CBME) Regulations, 2023 issued vide No. U.14021/181/2023-UGMEB dated 01/08/2023 as reproduced below respectively, the said student was not promoted to Phase II MBBS

"As prescribed in the erstwhile Medical Council of India Regulations on Graduate Medical Education, 1997, clause 8 passing in 1st Professional is compulsory before proceeding to 2nd MBBS training. It is to inform all the students that unless the students pass successfully in the 1st MBBS examination they will not be promoted to 2nd MBBS.

Moreover, if a candidate has failed to pass in the Supplementary Examination he will have to repeat the 1st MBBS Course Curriculum and appear for the University Examination of 1st MBBS with the new batch" and

"At the end of each professional year university examination will be conducted. If any student fails to clear university examination, he will appear in supplementary examination.

Supplementary examinations and declaration of results shall be processed within 3-6 weeks from the date of declaration of the results of the main examination for every professional year, so that the candidates, who pass, can join the main batch for progression.

If the candidate fails in the supplementary examination of first MBBS, he shall join the batch of next academic/subsequent year. There shall be no supplementary batches. Partial attendance of examination in any subject shall be counted as an attempt.

- *A candidate, who fails in the First Professional examination, shall not be allowed to join the Second Professional.*
- *A candidate, who fails in the second Professional examination, shall be allowed to join the third Professional Part I training, however he shall not be allowed to appear for the examination unless he has passed second professional examination.*
- *A candidate who fails in the third Professional (Part I) examination shall be allowed to join third Professional part II training, however he shall not be allowed to appear for the examination unless he has passed second professional examination”; and*

Whereas, the said student subsequently appeared in Phase I MBBS (Regular Examination – Session July 2024) with his Junior Batch 2023, was declared **Pass** vide Notification No. 1/MBBS 1st Year Examination of July 2024 dated 05/09/2024, and subsequently was promoted to Phase II MBBS with Batch 2023 vide this Office Order No. 549-RA(SS) of 2024 dated 07/09/2024; and

Whereas, the Hon’ble High Court of J&K and Ladakh, in WP(C) No. 2766/2024 titled *Aqib Ali Khan Vs Union Territory of J&K & Others*, vide Order dated 03/02/2025, the operative part of which is reproduced as under;

“In the light of this situation, this Court directs the Principal Government Medical College, Sgr, Kashmir as well as University of Kashmir to admit the petitioner for his second year supplementary examination (MBBS) which is said to commence from March, 2025 onwards and for enabling him to appear in the said examination all the needful to be done at the end of the Government Medical College, Srinagar in terms of assessment exercise to be done so that the petitioner is able to take his second year supplementary examination without any miss”; and



Whereas, pursuant to the said directions, the University of Kashmir allowed Mr. Aaqib Ali Khan to appear in Phase II MBBS (Supplementary Examination – Session May 2025) with Batch 2022 which was scheduled from 07/05/2025, but was declared **Fail**; and

Whereas, the candidate again appeared in Phase II MBBS (Supplementary Examination – Session Dec 2025 – Jan 2026) conducted by the University of Kashmir with Batch 2023 held from 17/12/2025; and

Now, therefore, in view of the above and pursuant to the CBME Regulations, 2023 issued by the National Medical Commission, **Mr. Aaqib Ali Khan (Batch 2022), having recently appeared in the Phase II MBBS Supplementary Examination with Batch 2023, is hereby promoted to Phase III Part-I MBBS with Batch 2023 from the date of completion of the said Examination.**

He is directed to report to the Heads of the concerned Departments for Clinical Postings and Theory Classes. He is hereby allotted **Batch H** for Clinical Postings.
