**Subject:- Unauthorized absence and Final Show Cause Notice thereof.**

Whereas, Medical Superintendent Govt. Lalla Ded Hospital Srinagar vide communication No. LHD/Est-II/542 dated 09-06-2023 had reported that you have initially applied for 30 days earned leave with effect from 01-09-2021 which was sanctioned vide order No:- LDH/Est-II/1071-1073 dated:-17-09-2021; and

Whereas, you were supposed to join your duties on 01-10-2021 but have failed to resume your legitimate duties on the stipulated date and continued to remain on unauthorized absence without any intimation to the immediate controlling officer/superiors neither submitted any leave application form for extension of leave; and

Whereas, you were served upon duo notices by the concerned Medical Superintendent on 25-01-2023 and 12-04-2023 on your residential address and was also published in two leading daily newspapers of Kashmir division too, for seeking reply regarding your unauthorized absence from the legitimate duties; and

Whereas, you did not bother to attend upon the instructions embodied in the correspondences presumably by appearing in person before the concerned Medical Superintendent or could furnish the reply to the notices served upon till date and it seems that you are not interested to resume your legitimate duties; and

Whereas, you were also served notice by this office vide No:- AH-9/Est-II/MC/2023/4288-96 dated:-10-08-2023 to your residential address seeking the reply regarding your unauthorized absence from the legitimate duties; and

Whereas, you submitted your reply forwarded by the Medical Superintendent Govt. Lalla Ded Hospital Srinagar vide NO:-LDH/Est-II/1222 Dated:- 05-09-2023 with the remarks that you have not joined your duty back and your reply was examined by the authorities and it was found devoid of any merit and it seems that you are not interested to resume the duties and serve the department anymore.

Now, therefore, before your appointment as Jr. Grade Nurse is terminated, you are hereby directed to explain your position as to why the action contemplated is not taken against you; you should personally attend this office with your reply by or before **15<sup>th</sup> of February 2024** on any working day.

In case of your failure to report this office along with your explanation, it shall be presumed that you have nothing to say in your defense and your appointment shall be terminated with effect from the date of your absence without further notice in terms of **Article 128 of JKCSR 1956.**
