Terms and Conditions

- 1) The candidates shall report to the office of the Principal/Dean, Govt. Medical College Srinagar for joining within a period of twenty one (21) days, from the date of issuance of this order, failing which their engagement as such shall stand cancelled without any further notice and the waiting list will be operated accordingly.
- 2) The arrangements shall be purely on temporary basis and shall not confer upon the candidates any special claim/right for their appointment against the said posts on regular basis as and when the same are filled through the Jammu and Kashmir Public Service Commission under rules.
- 3) The candidates shall have to execute an agreement with the Government on the prescribed form in terms of S.O 364 of 2020 Dated: 27-11-2020.
- 4) The engagement shall be for a period of one year or till the posts are filled up on regular basis on the recommendations of Jammu and Kashmir, Services Selection Board, whichever is earlier.
- 5) The engagement so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections/promotions are made in accordance with the recruitment rules governing the posts, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.
- 6) The salary in favour of the engaged candidates shall not be released unless a satisfactory report is received from the Criminal Investigation Department, J&K. Besides, the engagee shall deposit an affidavit duly attested by 1st Class Judicial Magistrate to the effect that if on verification any adverse report is received, her/his engagement shall be deemed to have been cancelled ab-initio.
- 7) The engagement shall be governed by the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O 364 of 2020 Dated: 27-11-2020.

- 8) The engagement shall be subject to the outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
- 9) The engagee shall give an undertaking in the shape of an affidavit duly attested by 1st Class Judicial Magistrate to the effect that if on verification, his/her Qualification/Date of Birth/Reserved category certificate from the concerned issuing authorities are found fake/forged, his/her engagement as "Medical Officer on Academic Arrangement Basis" in Govt. Medical College & Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her. In that case, he/she will not claim for any dues from the Govt. Medical College Srinagar and Its Associated Hospitals.
