Whereas, vide this office advertisement notification NO: Micro /HOD/2024/NCDC /1024-31 dated:11-12-2024, online applications were invited from eligible candidates for selection/engagement as Infection Control Nurse under National Programme on Anti-microbial resistance containment in the Department of Microbiology Govt. Medical College Srinagar with the following Criteria;
