Subject: Notice regarding deficiency of documents.

Whereas, this office vide notice No. 05 AH of 2024 Dated: 05-12-2024, invited applications from the eligible candidates of the Union Territory of Jammu & Kashmir for selection/engagement against posts of various categories which include the posts of Clinical Psychologist, Child Psychologist & Rehabilitation Psychologist on Academic Arrangement Basis (AAB) in terms of S.O. 364 of 2020 Dated: 27-11-2020 with eligibility parameters;

**"Master Degree in Psychology with M. Phil in Clinical Psychology from any Institution or University recognized by Rehabilitation council of India. At least 2 years experience in Child/ Adolescence Mental Health/ Clinical Psychology from an institution duly recognized by National Medical Commission of India/University duly recognized by University Grants Commission".**

And Whereas, pursuant to the directions of the Hon'ble CAT, Srinagar in O.A./ 916/2024 (Srinagar), your application forms for the above mentioned posts were received at your own risk and responsibility;

And whereas, all the application forms received in response to the aforementioned notification were got examined/ scrutinized by a panel of experts from the concerned discipline;

And Whereas, upon scrutiny/examination, it came to fore that your application forms are deficient/ do not meet the eligibility criteria for the above mentioned posts owing to the lack of basic prescribed qualification i.e. M. Phil in Clinical Psychology and as such you are not eligible for the said posts if you do not possess the prescribed qualification. However in the interest of fair play, it has been decided to afford you an opportunity with respect to the instant case.

Now therefore, through the medium of this notice you are hereby directed to submit, if you are in possession of any document/certificate in support/defence of your candidature for the aforementioned posts by or before 05<sup>th</sup> March 2025, 04:00pm, failing which it shall be deemed that you are not possessing the prescribed qualification for above mentioned posts and your candidature for these posts shall be rejected without any further notice.
