## NOTICE

Whereas, vide this office notice No. 05 AH of 2024 Dated: 05-12-2024. applications were invited from the eligible candidates of the Union Territory of Jammu & Kashmir for selection/engagement against posts of Psychology/ Psychiatry/Occupational Therapy/ Audiometry cadres on Academic Arrangement Basis (AAB) in terms of S.O. 364 of 2020 Dated: 27-11-2020;

And Whereas, the applications received in response to the aforementioned notification were got examined/scrutinized by a panel of experts from the concerned discipline;

And Whereas, upon scrutiny/examination, the expert panel pointed out certain deficiencies in respect of the some candidates.

And Whereas, in view of the observations made by the experts panel and in the interest of fair play, the candidates whose application forms were found deficient in respect of certain documents/qualifications, were given/afforded an opportunity to make up their respective deficiencies within a period of 03 (three) days from the issuance of the notice issued under endorsement No. GMCs/HS-IV/G-86/2025/6316-18 Dated: 12.02.202, failing which it shall be presumed that they are not fulfilling the eligibility criteria and their candidature shall be rejected without any further notice.

And whereas, in response to the said notice, one candidate namely Ms. Naziya Fayaz Baba, who had applied for the posts of Clinical Psychologist, Child Psychologist & Rehabilitation Psychologist, has submitted a representation within the stipulated time period along with some documents in support of her claim:

And whereas, the representation along with the supporting documents submitted by the said candidate were put before the expert panel for scrutiny. Upon reexamination of the documents of the forenamed candidate, it came to fore that the candidate is not fulfilling the eligibility criteria owing to the lack of requisite quantum of experience prescribed for the posts of Clinical Psychologist, Child Psychologist and Rehabilitation Psychologist.

Now therefore, in the light of above facts and circumstances, the candidature of Ms. Naziya Fayaz Baba for the posts of Clinical Psychologist, Child Psychologist and Rehabilitation Psychologist is hereby rejected
