The said incumbent is directed to report to the Head of the Department, **Psychiatry**, Government Medical College, Srinagar for further duties:-

Terms and Conditions:-

- 01. The engagee shall have to join his assignment within a period of (21) days, failing which his engagement as such shall be cancelled without any further notice and the candidate falling in waiting list shall be considered for such engagement in his place.
- 02. The hired person shall be required to submit the following documents/certificates in the Office of Administrative Officer Govt. Medical College, Srinagar:-
 - I. Date of Birth Certificate.
- II. Domicile Certificate.
- III. Qualification Certificate and;
- IV. Any other document as required under rules.

- 03. This contractual engagement is not being made against any substantive post and as such will not in any case confer any right upon the engagee to claim regular appointment or seek extension when the scheme gets over/funds get exhausted.
- 04. The contractual term of one year is terminable even before his term expires without any notice/citing any reason in case the performance is not satisfactory.
- 05. The engagement will be for a period of one year or till continuation of the scheme whichever is earlier and will be extended subject to the good performance of the candidate/approval of the competent authority and:
 - a) Availability of Budget;
 - b) Continuation of this scheme.
- 06. The engaged candidate shall have to execute an agreement that he/she will not leave the Department before the completion of one year's contract. However, abandoning/termination of the engagement under the scheme will require one month's prior notice on either side, failing which the remuneration shall not be paid for one month to the incumbent which shall always remain in deposit with the Department and shall be released on completion of sanctioned term.
- 07. The engagee has to work as per the job assigned under the above referred project/scheme.
- 08. If the engagee at any point of time willfully neglects or refuses to perform the assigned duties, his/her engagement shall be terminated forthwith without any notice and he shall not be entitled to any salary for such period.
- 09. The engagee shall also submit an undertaking in the shape of an affidavit duly attested by the 1st Class Judicial Magistrate to the effect:-
- i) That in case an adverse report about his Qualification, Date of Birth, Domicile Certificate etc. if any, is received from the competent authority to whom the references shall be made by this office, the candidate shall have no right to claim his engagement as **Data Manager** and his engagement as such shall be deemed to have been cancelled ab-initio. He will not also claim for any dues from Govt. Medical College, Srinagar as well in that case and next candidate falling in the waiting list will be considered for engagement as **Data Manager**.
