Pending clearance by the Departmental Promotion Committee (DPC), without prejudice to the seniority of others and as recommended by the Establishment Committee in its meeting held on 18-03-2026, sanction is hereby accorded to the placement of below mentioned Laboratory Assistants presently working in the Pay Level-4 (25500-81100) as I/c Laboratory Technician etc. Pay-Level-6 [35400-112400] in their own pay and grade with charge allowances as admissible under rules purely on Stop Gap Arrangement basis for a period of six months or till the posts are filled up strictly in accordance with rules/norms by the Competent Authority/DPC, whichever is earlier with immediate effect against the available vacancies of Laboratory Technician etc. in the Pay Level-6 on the establishments as shown against each;

**The above placement is subject to the following terms and conditions, that:**

1. The placement is temporary and shall not confer any preferential right on the officials to hold the posts on substantive basis or claim promotion which shall be made in accordance with the rules by the competent forum i.e. DPC.
2. The placement is purely on Stop Gap Arrangement Basis for a period of six months or till the posts are filled up by the competent authority/DPC whichever is earlier.
3. The placement is subject to the final outcome of the writ petition(s) pending before Hon'ble Court of Competent Jurisdiction or any order already passed in this regard and not in the immediate notice of Establishment Committee.
4. The concerned DDOs shall ensure that the officials are neither under suspension nor involved in embezzlement/criminal case, etc.
5. The placement is also subject to final outcome of departmental proceedings, if any, pending against any official.
6. The placement is further subject to the clearance and acceptance of the service details/records submitted in the prescribed J&K Human Resource Management System (HRMS) portal.
7. The concerned DDOs shall ensure that appointment of the officials is genuine and the appointment orders in respect of the promotees have been issued by the competent authority in terms of the directions/instructions issued by the Government from time to time before recording necessary placement entries in the service records of the officials.
