Whereas, Medical Superintendent, Govt. Psychiatry Diseases Hospital, Srinagar reported that you have been unauthorizedly absent from duties w.e.f 25-02-2023 followed by another communication as documentary proof vide letter No. Psy/2143-45 Dated: 01-03-2023 and Psy/Est-III/2319 Dated: 20-03-2023 respectivley; and

Whereas, as per the reports received you were placed under suspension vide Order No. 215 AH of 2023 Dated: 03-04-2023 issued under endorsement No. AH-09/Est-III/1612-13 Dated: 03-04-2023; and

Whereas, this office approached Medical Superintendent, Govt. Psychiatry Diseases Hospital, Srinagar seeking the present status of your case vide letter No. AH-09/Est-III/2023/2585-86 Dated: 19-05-2023 and in response Medical Superintendent concerned stated that you have been apprehended by police station hazratbal Srinagar on 23-02-2023 and are in their custody as per the application submitted by the application of your mother vide No. Psy/Est-III/490 Dated:22-05-2023; and

Whereas, this office again approached concerned Medical Superintendent for want of present whereabouts of your case for want of FIR copy vide letter No. AH-09/Est-III/2023/2689 Dated: 23/05/2023 and in response Medical Superintendent vide letter No. PA/MS/Psy/575 Dated:30/05/2023 furnished the FIR copy sent from Station House Officer, Police Station Nigeen revealing that you have been arrested in case FIR No. 21/2023 U/S 8/20, 21, 22 NDPS Act of this Police Station and the challan of the case was produced before the Hon'ble court of 2<sup>nd</sup> Additional Session Judge, Srinagar against you on 23-05-2023 and further revealing that you are lodged under PSA in koth Bhalwal Jail Jammu vide PSA Order No. DIVCOM-"K"/49/2023 Dated: 01-05-2023; and

Whereas, the latest whereabouts furnished by concerned Medical Superintent forwarded the report of Station House Officer, Police Station Nigeen vide No. NGN/24/5-A/1600 Dated: 08-10-2024 revealing that you are arrested in case FIR No. 21/2023 U/S 8/20,21,22 NDPS Act and subsequently detained under PSA in Koth Bhalwal Jail Jammu vide Divisional Commissioner letter DIVCOM-"K"/49/2023 Dated: 01-05-2023.
