Subject: Assignment of Charge of Technical Supervisor.

In view of the retirement of Mr. Shabir Ahmad Sofi, I/C Technical Supervisor, w.e.f 31-05-2026, and in the interest of administration, it is hereby ordered as under:

1. Mr. Ghulam Nabi Bhat, Telephone Supervisor, shall look after the charge of I/C Technical Supervisor in addition to his own duties. He shall take over the charge from the said official after conducting a proper inventory of the assets.
2. Further, Mr. Ghulam Nabi Bhat shall be placed as I/C Technical Supervisor w.e.f. 01-06-2026, consequent upon the vacation of the post by Mr. Shabir Ahmad Sofi on his superannuation.

However, this arrangement shall be subject to the following terms and conditions:

- a. It shall be purely temporary and shall not confer any preferential right on the official to claim the post on a substantive basis or seek promotion, which shall be governed strictly by the applicable rules.
- b. This shall be without prejudice to the seniority of others and subsist on filling up the post on regular basis by the Departmental promotion Committee.
- c. This arrangement is also subject to the outcome of any court orders, if applicable.
