MEMORANDUM OF UNDERSTANDING FOR IMPARTING OF PRACTICAL TRAINING TO THE B.SC AND POST BASIC B.SC NURSING STUDENTS

The present memorandum of understanding (MOU) is being signed between:

Government Medical College Srinagar
And
(Applicant Nursing College/Hospital)
The Memorandum of Understanding (MoU) is entered between Govt. Medical College Srinagar and(Applicant Nursing College/Hospital), for imparting Practical Training to the B.Sc and Post Basic B.Sc Nursing candidates in the following four specialities:
1. Obstetrics & Gynaecological Nursing
2. Paediatric Nursing
3. Psychiatric Nursing
4. Community Nursing
Whereas, the(Applicant Nursing College/Hospital), is registered/affiliated with J&K Nursing Council vide Order No, and Indian Nursing council vide registration No and has applied for the Tie-Up with GMC Srinagar.
Whereas, in terms of Govt order No 197-HME of 2009, dated 05/05/2009 followed by Circular No. 01-JK(HME) of 2023 dated 24/01/2023 applied for the Tie-up
with Govt Medical College, Srinagar, to impart Clinical training to the enrolled students for BSc Nursing/Post BSc Nursing courses.
NOW, this MoU aims to capture the understanding reached between Government Medical College Srinagar and(Applicant Nursing College/Hospital),.
UNDERSTANDING:

Whereas, both the institutions under this MoU agreed to enter into agreement with each other as below to provide internship to students enrolled in the Institution to be approved by the competent authority

SCOPE OF THE MOU:

Whereas, the vision of this agreement is to address the Practical Training among student community and also to help them to gain a head start in their career through the use of such trainings. The parties agree to use best efforts towards fulfilment of their respective commitments in realising this intent of imparting Clinical training for the students of BSc Nursing/Post BSc Nursing courses.

Whereas, the member of institutions/colleges leveraging the scope outlined in this MoU for its students, will be doing so under the then prevailing terms and conditions laid by the competent Authority from time to time in this behalf.

Whereas, the terms & conditions for imparting clinical/Practical classes at Associated Hospitals of Government Medical College, Srinagar will be initially for a period of 02 years.

Whereas, that the Govt. Medical College Srinagar will conduct practical classes of assigned students and will provide all the logistic Support to students enrolled for practical training in the above mentioned four specialities, subject to the feasibility.

Whereas, the institute will pay the training fee/charges as per Govt Order No. 197-HME of 2009, dated 05/05/2009 applied for the Tie-up with Govt Medical College Srinagar to impart Clinical training to the enrolled students for BSc Nursing/Post B.Sc Nursing Courses.

Whereas, the periodical review taken by the University of Kashmir of the said college and non fulfilment of the terms and conditions will attract termination of MOU without any prior notice if the said conditions are not fulfilled and the said college will also regularly submit the renewal of the documents from the Indian Nursing Council during the operation of the MOU.

Whereas, the applicant college has to deposit the requisite Fee of Rs. 50,000/- (Rupees: Fifty Thousand Only), as security deposit (refundable under certain circumstances), in the form of Demand Draft in favour of Chief Account Officer GMC Srinagar, and a fee of Rs. 5000/- (Rupees: Five Thousand Only) for each student (non-refundable) for pursuing clinical training in GMC Srinagar.

Whereas, the applicant college has to provide a separate undertaking duly attested by Judicial Magistrate Srinagar complying with the terms and conditions issued in this regard by Government from time to time and ascertain the responsibility of students for remaining disciplined during the training period at GMC and Associated Hospitals, Srinagar.

Other Terms and Conditions:

- That the concerned recognised Institution shall enter an M.O.U, with Government Medical College Srinagar.
- The applicant Institution shall seek proper approval from Government Medical College Srinagar as per the norms after signing M.O. U with GMC Srinagar. The training of these students in batches shall be decided by Government Medical College Srinagar subject to feasibility.
- That the maximum period of validity of M.O.U shall be of Two Years (renewable) if otherwise feasible or extendible after receiving the inputs from concerned HOD's and Medical Superintendents.
- Memorandum of Understanding shall be signed only with Nursing Colleges / Institutions affiliated with the J&K Nursing Council.
- Tie- up shall be provided to the present intake capacity of applicant Institutions.
- That the concerned Institutes shall submit an affidavit duly attested by Judicial Magistrate for abiding all the rules and regulations of this Institution (GMC Srinagar).
- Applicant Institution's should take responsibility to provide the facilities viz.
 Transport and other logistics facilities for the trainees during the period of Training.
- No Library facilities /ID Cards shall be provided to the trainees during the period of Training from Government Medical College, Srinagar and its associated Hospitals. However, the Medical Superintendent of concerned Hospital shall provide a Unique ID Code to these trainees. The students shall return this unique ID code to the concerned HOD/ Medical Superintendent after completion of training.
- The student shall get a clinical training Certificate, signed by concerned HOD and Medical Superintendent after which Final Certificate will be issued by Government Medical College Srinagar.
- Fee shall be paid as applicable vide Government Order No. 197 HME of 2009, Dated:05/05/2009. The fee so deposited shall be maintained by the office of the Financial Advisor / Chief Accounts Officer (CAO), GMC Srinagar.
- The applicant Institution(s) shall seek proper approval for training of students from the HoI, Government Medical College Srinagar as per the norms after signing Memorandum of Understanding with GMC Srinagar.

- Nursing Tutor(s) from the applicant Institution(s) shall accompany the Trainees as per the norms, at the time of approval of training at GMC & Associated Hospital, Srinagar.
- That the applicant Institution(s) shall abide by all the Orders/directions issuing/issued time to time by the Government Medical College Srinagar.
- The Government Medical College, Srinagar, has the authority to withdraw the MoU, at any time, depending upon the feasibility of accommodating the students in the institution.
- The roster for the trainees shall be decided by GMC Srinagar, subject to the feasibility.
- The Government Medical College, Srinagar, has discretion to allow the number of students for undergoing Internship Training Programme at GMC Srinagar, as per the availability of slots.
- Any other MoU signed between GMC Srinagar & applicant Institution(s) for practical/clinical training shall deemed to be considered as null & void, after signing of this MoU (Fresh).
- All the applicant Institution(s) shall have to attach following documents with the MoU
 - a. Letter of affiliation with Indian Nursing Council / J&K Nursing Council
 - b. Letter of affiliation form the recognised University
 - c. Approved copy of present intake capacity
