- The above placement is further subject to the clearance and acceptance of the service details/records submitted in the prescribed J&K Human Resource Management System (HRMS) portal.
- The concerned DDO's shall ensure that initial appointment of the officials is genuine and the appointment order in respect of these promote have been issued by competent authority in terms of the norms issued by Government from time to time.
