- The placement is purely on Stop Gap Arrangement Basis for a period of six months or till the posts are filled up by the competent authority/DPC, whichever is earlier.
- The placement shall be subject to the final outcome of writ petition(s) pending, if any, in Hon'ble Court of Law.
- The placement is subject to confirmation by the Departmental Promotion Committee.
- The placement is subject to the clearance and acceptance of service records/details submitted in the prescribed J&K HRMS Portal at their concerned DDO(s).
- The concerned DDO(s) shall ensure that the appointment orders in respect of the officials have been issued by competent authority in terms of the norms issued by Government from time to time before entering the necessary promotion entries in their Service Records.
- The placement is further subject to Vigilance Clearance from General Administration Department (Vigilance), J&K, which shall be communicated separately by this office.
- The placement is further subject to the amendment(s) in the existing recruitment rules during the process of finalization at the Administrative Level.
- The officials shall continue to discharge their duties at their present place of postings. Transfers/adjustments, if necessary, shall be issued separately.
