Pending clearance by the Departmental Promotion Committee (DPC), without prejudice to the seniority of others and as recommended by the Establishment Committee in its meeting held on 21-04-2026, sanction is hereby accorded to the placement of **Aijaz Nabi Putoo**, Lab Technician/Lab Technologist/ Mycology Technician etc. presently working in the Pay Level-6 (35400-112400) as I/c Lab. Technician/ Research Technician etc carrying pay level-6D in his own pay and grade with charge allowances as admissible under rules purely on Stop Gap Arrangement basis for a period of six months or till the post is filled up strictly in accordance with rules/norms by the Competent Authority/DPC, whichever is earlier.

**The above placement is subject to the following terms and conditions, that:**

1. The placement is temporary and shall not confer any preferential right on the official to hold the post on substantive basis or claim promotion which shall be made in accordance with the rules by the competent forum i.e. DPC.
2. The placement is purely on Stop Gap Arrangement Basis for a period of six months or till the post is filled up by the competent authority/DPC whichever is earlier.
3. The placement is subject to the final outcome of the writ petition(s) pending before Hon'ble Court of Competent Jurisdiction or any order already passed in this regard and not in the immediate notice of Establishment Committee.
4. The concerned DDO shall ensure that the official is neither under suspension nor involved in embezzlement/criminal case, etc.
5. The placement is also subject to final outcome of departmental proceedings, if any, pending against any official.
6. The placement is further subject to the clearance and acceptance of the service details/records submitted in the prescribed J&K Human Resource Management System (JKHRMS) portal.
7. The concerned DDO shall ensure that appointment of the official is genuine and the appointment order in respect of the official has been issued by the competent authority in terms of the directions/instructions issued by the Government from time to time before recording necessary placement entries in the service records of the official.
8. The official shall continue to work at his present place of posting till further orders.
