In terms of SO 364 of 2020 Dated: 27.11.2020, sanction is hereby accorded to the grant of 5th and last extension for a further period of one year in favour of the below mentioned Medical Officers/Casualty Medical Officers engaged on Academic Arrangement Basis vide Government Order No. 425-JK(HME) of 2021 Dated: 01.06.2021 from the dates specified against each on the same terms and conditions as laid down in their intial engagement order. However, this arrangement shall automatically cease/cancel after one year from the date of expiry of this last extension and the Medical Officers shall have to furnish an affidavit (1st class Judicial) in the office of their respective DDO/Medical Superintendents deposing therein that they will not claim for regularization/continuation of services and the concerned DDO/Medical Superintendent shall ensure that they will obtain the requisite agreement/affidavit as per the S.O prescribed for the purpose before disbursement of salaries in their favour.

Furthermore, the concerned DDO's/Medical Superintendent's, shall ensure that the doctors are assigned the duties strictly as per the S.O. 364 of 2020 Dated: 27.11.2020.
