1. The selection of the above candidate shall be **purely provisional** and subject to verification of original documents/testimonials, educational qualifications, registration with the concerned Medical Council/NMC and

fulfilment of all eligibility conditions prescribed in the Advertisement Notice.

2. The engagement shall be subject to satisfactory verification of **Character and Antecedents by the Criminal Investigation Department (CID), J&K** in terms of Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021 read with Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021.
3. Formal engagement orders shall be issued only after receipt of a satisfactory CID verification report.
4. In case the candidate is found ineligible at any stage or any information furnished by the candidate is found to be false/concealed, the selection shall be cancelled forthwith without any further notice.
