The appointee shall be allowed to join only on the production of following certificates in original to be verified subsequently:

- a. Date of Birth Certificate.
- b. Qualification Certificate.
- c. Domicile Certificate.
- d. Medical Fitness Certificate from Chief Medical Officer (CMO) concerned.
- e. No Objection Certificate from District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District. If the candidate has taken loan for self employment from DIC/Employment Department, she shall relinquish the proprietorship of Unit/Enterprise and also stakes if any in such self employment unit/enterprise before joining the Government Service. She shall be required to repay the entire liability in suitable EMI's to be worked out by the DDO concerned from her salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of Proprietorship and stakes, if any, in such self employment unit Enterprise and recovery to be made and also personally monitor its recovery.
