- Their stipend shall be paid from the date of their Joining as shown against each.
- The doctor(s) thus engaged as House Surgeon shall submit their joining report in the concerned departments & should reach to the Office of the Registrar Academics, Government Medical College, Srinagar immediately.
- Before disbursing the monthly stipend all DDO's must verify their Medical Registration issued by J&K Medical Council.
