

That the above promotion/confirmation is subject to the final outcome of the writ petition(s) pending before Hon'ble Court of Competent Jurisdiction or departmental proceedings pending against the official(s), if any or any order already passed in this regard and not brought into the notice of Departmental Promotion Committee.
