- Their stipend shall be paid from the date of their Joining as shown against each.
- The doctor(s) thus engaged as House Surgeons shall submit their joining report in the concerned departments & should reach to the Office of the Registrar Academics, Government Medical College, Srinagar immediately.
- Before disbursing the monthly stipend, the concerned DDO must verify their Medical Registration issued by J&K Medical Council.
- In case of adverse report with regard to their character and antecedents received from Additional Director General of Police, CID or the candidate leaves the job before receipt of CID verification, they shall have no claim for House Surgeon benefits i.e. Experience certificate and Salary.

 If the candidate left the job in midterm, no Experience certificate shall be issued in her favour.
