Pursuant to the selection Notification No. 03-RA of 2023 Dated. 14-08-2023 and satisfactory verification of antecedents by Criminal Investigation Department (CID), Dr. Seerat Bashir is provisionally engaged as Senior Resident in the Department of ENT, Government Medical College, Srinagar on Academic Arrangement basis under S.O. 364 of 2020 Dated. 27-11-2020 initially for a period of one year which is extendable upto (03) years on basis of good performance to be certified by the concerned HOD.

The appointment of the above doctor is subject to the following terms and conditions: -

1. Before joining the Department, the selected candidate shall submit an affidavit in the office of the Registrar Academics, Government Medical College, Srinagar duly attested by the Judicial Magistrate to the effect that: -
 - a. she is not an In-service candidate and in case it comes out at any stage that the deponent has misrepresented/ concealed the facts she shall be punished under Rules which includes confiscation of the Registration of the Doctor.
 - b. she will not participate in any kind of strike during the period of her tenure engagement. In the event she proceeded on strike, her tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.

- c. she shall remain disciplined during the tenure period, any kind of misconduct shall make her liable for termination without any prior notice.
 - d. she is not involved in any criminal activity, nor is there any FIR pending or registered against her in any criminal department or police station.
 - e. she shall not claim any experience certificate in case she leaves Senior Resident ship before completion of first year.
 - f. she will not indulge in any private practice. In case she is found doing private practice her appointment shall be liable for termination without any notice.
2. The above doctor shall have to execute an agreement with the institution on a prescribed format (Form A) with regard to the various terms and conditions applicable during academic arrangement same can be downloaded from the official website of Government Medical College, Srinagar.
 3. The appointee is required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have cancelled.
 4. The Senior Resident appointed on Academic Arrangement basis shall be paid as per S.O. 364 of 2020 Dated. 27-11-2020.
