NOTIFICATION

Whereas, on the basis of merit obtained in the written examination held on 24.04.2024, Ms. Bilkees Ashraf C/O Mustafa Bashir R/O Gundbal Andergam, Pattan was selected as Infection Control Nurse under National Programme on Antimicrobial Resistance Containment in the Department of Microbiology Govt. Medical College, Srinagar vide notification No:MC/Micro/Result/Sel/NPARC/287-90 dated: 07.06.2024 with the directions to report Govt. Medical College, Srinagar within two days from the date of issuance of the notification for filling up of e-verification rolls for obtaining her Character and Antecedents from the Criminal Investigation Department;

Whereas, despite lapse of more than 20 days, Ms. Bilkees Ashraf did not report Govt. Medical College, Srinagar for the intended purpose;

Whereas, in the interest of fair play and probity, Ms. Bilkees Ashraf was provided one more and last opportunity to report. Govt. Medical College, Srinagar by or before 05.07.2024 for filling up of e-verification rolls for obtaining her Character and Antecedents from the Criminal Investigation Department vide No: GMC/Micro/Sel/ICN/343-345 dated: 28.06.2024 on her residential address;

Whereas, despite lapse of further 07 days, Ms. Bilkees Ashraf has not reported Govt. Medical College, Srinagar for the intended purpose which clearly indicates that she is not willing to take up the said position;

Whereas, this Department is left with no choice but to select the candidate next in merit for smooth implementation of National Programme on Antimicrobial Resistance Containment in the Department of Microbiology Govt. Medical College, Srinagar;

Whereas, as per merit notification list issued vide C/Micro/Result/Sel/NPARC/287-90 dated: 07.06.2024, Mr. Nasir Ahmed Bhat S/O Saiffudin Bhat/R/O Aragam Bandipora is falling next in the merit;

Now, therefore, keeping in view the above facts, sanction is hereby accorded to the:
