- That, the concerned DDO shall ensure that the appointment order in respect of the above official has been issued by competent authority in terms of the norms issued by Government from time to time before entertaining the necessary promotion entries in the service records of the respective official.
- That, the official shall continue to discharge his duties at his present place of posting till further orders.
