Without prejudice to the seniority of others and subject to the confirmation by Departmental Promotion Committee, sanction is hereby accorded to placement of Mr. Mohd Ayoub Mir, Receptionist carrying pay Level-4 (25500-81100) as I/c Sr. Receptionist in pay Level-6E (35900-113500) in his own pay and grade with charge allowances as admissible under rules with effect from 27-06-2024 temporarily on Stop Gap Arrangement Basis on the available vacancy at Govt. • That, the above arrangement is subject to the final outcome of the writ petition(s) pending before Hon'ble Court of Competent Jurisdiction or departmental proceedings pending against any official, if any.

That, the above arrangement is further subject to the clearance and acceptance of the service details/records submitted in the prescribed J&K

That, the concerned DDO shall ensure that the appointment order in respect of the above official has been issued by competent authority in terms of the norms issued by Government from time to time before entertaining the necessary promotion entries in the service records of the respective official.

• That the placement is subject to the amendment and rectification of the recruitment rules from the Administrative Department during the course of finalization process of recruitment rules.

• That, the official shall continue to discharge his duties at his present place of posting till further orders.
