The selected pharmacists shall execute an agreement with the department through Block Medical Officer, attested by 1st Class Magistrate that He/she will abide all the terms and conditions as laid by the Department and shall work under the supervision of Block Medical Officer Hazratbal and shall not claim any regularization in the department in lieu of this agreement.

03. Engagement of Pharmacist in PMBJK is a temporary arrangement for 03 years on performance basis and shall not confirm any right for permanent absorption/ regularization in the department and can be terminated anytime without any notice.

04. There is no fixed salary and the working is purely on profit basis.

05. Out of total 20% margin on MRP of each drug as per guidelines, registered pharmacist shall be provided 15%.

06. Only Medicines supplied by PBBI should be sold at the Kendra and all the billing should be done by using software provided by BPPI.
