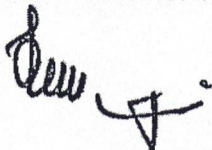

- f. Any other documents as required under rules.

The appointment of aforementioned candidate shall further be subject to the following conditions:-

- i. The appointees shall report to the Principal, Government Medical College Srinagar, within a period of twenty-one (21) days from the date of issuance of this order, failing which they shall forego their right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further Notice.
- ii. Each appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his/her Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his/her appointment as Clinical Psychologist and Medical Physics Technician (as the case may be) shall be deemed to have been cancelled ab- initio and the legal action as warranted under rules shall be initiated against him/her.
- iii. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate is received from the concerned Authorities/Agency .
- iv. That if the candidates have taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, they shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self- employment unit/enterprise before joining the Government service, they shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from their salary. DDO concerned shall obtain an affidavit from the concerned appointees regarding both relinquishments of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

v. The appointees shall be on probation for a period of two years.

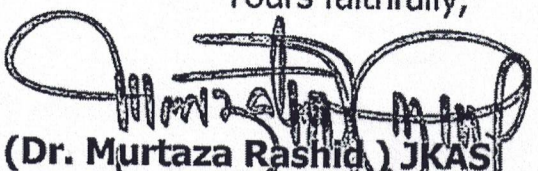
vi. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.



- vii. - viii. The interim arrangement, if any, made on contract/deputation or on academic arrangement basis against the above posts, shall be deemed to have been terminated forthwith.
- ix. The appointment of the above candidates shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
- x. The appointment in Divisional cadre is non transferable from one Division to another or from one Medical College to another.
