Subject: Selection criteria for engagement of faculty under SO 364 of 2020 dated 27.11.2020 and Registrars/Demonstrators/Tutors in all Government Medical Colleges and Government Dental Colleges of J&K.

WHEREAS, Rule-6 of the Jammu & Kashmir Medical & Dental Education (Appointment on Academic Arrangement Basis), Rules, 2020 notified vide SO 364 of 2020 dated 27.11.2020 provides as under:

Selection Committee: (1) The selection of the candidates for the posts of teaching faculty in Medical/Dental/Ayurvedic/Unani Colleges and for the posts of Medical Officers shall be made by a Selection Committee comprising:

1	Administrative Secretary, Health & Medical Education Department	Chairman
2	Principal of the concerned Government Medical College/Dental College/Ayurvedic College/Unani College (as the case may be)	Member
3	HoD of the concerned discipline (not below the rank of Professor) in the concerned Medical College/Dental College & Director ISM in case of Ayurvedic College/Unani College. (In case of GMCs Anantnag, Baramulla, Handwara, HoD of the concerned discipline in GMC, Srinagar and in case of GMCs Doda, Kathua, Rajouri & Udhampur, HoD of the concerned discipline in GMC, Jammu shall be the members till such time the faculty of the appropriate level is in position in these new Medical Colleges).	Member
4	One expert in the relevant discipline to be nominated by the Government	Member

AND WHEREAS, in the Jammu & Kashmir Medical & Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, the selection criteria for engagement on faculty posts and Registrars/Demonstrators/Tutors have not been prescribed;

AND WHEREAS, the H&ME Department on several occasions received representations regarding adoption of different criteria in Government Medical Colleges and Government Dental Colleges of J&K for engagement of faculty and selection of Registrars/Demonstrators/Tutors;

AND WHEREAS, the case was examined in the Department and accordingly, a committee headed by Principal, Government Medical College, Jammu was constituted for formulation of uniform criteria for engagement of faculty on academic arrangement basis;

AND WHEREAS, extensive consultations were held with Principals of all Government Medical Colleges and Government Dental Colleges of J&K for finalization/adoption of uniform selection criteria for engagement of faculty and selection of Registrars/Demonstrators/Tutors in all Government Medical Colleges and Government Dental Colleges of J&K;

AND WHEREAS, all the Principals of Government Medical colleges and Government Dental Colleges of J&K submitted a proposal of uniform selection criteria for engagement of faculty and selection of Registrars/Demonstrators/Tutors which, after examination, has been accepted by the Administrative Department;

NOW, THEREFORE, uniform selection criteria for engagement of faculty posts viz. Professor, Associate Professor, Assistant Professor/Lecturers, in terms of the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020 notified vide SO 364 of 2020 dated 27.11.2020, and Registrars/Demonstrators/Tutors in all Government Medical Colleges and Government Dental Colleges of J&K, forming **Annexure-A, B, C & D** to this Government Order, are hereby issued with immediate effect





Research Publications: At least four Research publications (at least two as Associate Professor) (only original papers, meta-analysis, systematic reviews and case series that are published in journals indexed in Medline, PubMed, Central Science Citation Index, ScienceCitation Index, Expanded Embase, Scopus, Directory of Open Access Journals (DoAJ) will be considered. The Weightage shall be calculated @ 5 point per published/accepted paper, beyond minimum required Publications).	20
4.	Participation with oral presentation including invited for lectures/ guest lecturers/ oration in a National/International seminar /conference /workshop relevant to the discipline with the abstract/full paper published in the proceedings/souvenir of the seminar/conference/workshop. The Weightage shall be calculated @ 0.25 point for each paper presented.	04
5.	Participation with poster presentation of paper(s) in a National/International seminar/conference/workshop relevant to the discipline with the abstract/full paper published in the proceedings/souvenir of the seminar/conference /workshop. The Weightage shall be calculated @ 0.25 point for each pa presented.	02
6.	Credit for writing a Book or a chapter in a book of the specialty concerned as 1 st or 2 nd or 3 rd author (Foreign Book/National Book published with ISBN/ISSN) and assessed by the subject matter expert to be relevant to the subject and of a level where it can be accepted as a reference material for the post applied for. The Weightage shall be calculated @ 0.5 point for each Book /Chapter.	02

Mandatory norms of NMC/DCI for faculty appointment in broad specialties/super specialties shall be applicable. In case of a tie, candidates with higher merit in teaching experience shall be preferred. In case the tie remains unbroken, candidate with higher age shall be preferred. Candidates who have retired from NMC/DCI recognized Government Medical/Dental Colleges as Professors shall be engaged on the same post without any evaluation process, in the Government Medical/Dental Colleges where he/she has applied under SO 364. Only in case of competition in the specialty, the evaluation process as per the selection criteria shall be undertaken to calculate the merit.

Research Publications: At least two Research publications (only original papers, meta-analysis, systematic reviews and case series that are published in journals indexed in Medline, PubMed, Central Science Citation Index, Science Citation Index, Expanded Embase, Scopus, Directory of Open Access Journals (DoAJ) will be considered. The Weightage shall be calculated @ 5 point per published/accepted paper beyond minimum required publication.	20

Participation with oral presentation including invited lecturers/ guest lecturers/ oration in a National/International seminar /conference /workshop relevant to the discipline with the abstract/full paper published in the proceedings/souvenir of the seminar/conference/workshop. The Weightage shall be calculated @ 0.5 point for each paper presented.	04

Participation with poster presentation of paper(s) in a National/International seminar/conference/workshop relevant to the discipline with the abstract/full paper published in the proceedings/souvenir of the seminar/conference/workshop. 
