Pursuant to the Examination Cell Notification No. 20-EC of 2026 Dated. 02.07.2026 and No Objection Certificate issued by Administrative Department, Health and Medical Education Department vide No. HD-Gaz0Gen/690/2025-02 (E-7689572) Dated. 10.02.2026 and on the basis of Satisfactory verification report of Character & Antecedents received from Criminal Investigation Department (CID), J&K, Dr. Akhter Rasool Dar, MS, in-service doctor, is provisionally appointed as Senior Resident in the Discipline of Orthopaedics, Government Medical College, Srinagar in accordance with the Government Order No. 383-JK(HME) of 2024 Dated. 20.06.2024, for a period of one year which is extendable upto maximum **period of (02) years and (01) month only**, on the basis of good performance to be certified by concerned HOD, in order to complete remaining portion of Senior Residency, as the doctor has sworn on affidavit viz a viz experience certificate that he has earlier completed (11) months of Senior Residency from Govt. Medical College, Baramulla.

The appointment of the aforementioned doctor is further subject to the following terms and conditions: -

1. The selected candidate is supposed to submit his joining report alongwith an affidavit in the office of the undersigned duly attested by the Judicial Magistrate to the effect that: -
 1. He will not participate in any kind of strike during the period of his tenure engagement. In the event he proceeds on strike, his tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
 2. He shall remain disciplined during the whole tenure; any kind of misconduct shall make him liable for termination without any prior notice.

3. He is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him.
4. He shall not claim any experience certificate, in case he leaves Senior Residency before completion at least of six months.
5. He will not indulge in any private practice. In case he is found doing private practice his appointment shall be liable for termination without any further notice.
6. In case the doctor abandons his course midway, he shall be liable to the following penalties: -
 - a. Withholding of two increments.
 - b. Imposition of penalty to the tune of Rs. 2.0 lacs along with recovery of total amount paid to the delinquent doctor during the training of said course.
 - c. Ban from future participation in Government-sponsored educational programs or training courses for a period of (05) years.
2. The appointee is required to join within (21) days from the date of issuance of this order; failing which the order shall be deemed to have been cancelled.
3. The appointee shall be paid as per his Last Pay Certificate issued by the parent department.
