Whereas, on the recommendations made by J&K Service Selection Board vide no. SSB/Sel/Secy/1452-55 dated: 04-06-2012 conveyed to this Institution by Health and Medical Education Department vide No. ME/NG/64/2012 dated: 15-06-2012, Mr. Nath Pal Singh S/o Trilok Singh, R/o Dharamshala Singhan, Chadoora Budgam was appointed as Junior Pharmacist/Dresser in the pay scale of 5200-2400-20200 in Govt. Medical College Srinagar vide order no. 378 of 2012 dated: 07-07-2012 and was posted in Associated Hospitals Srinagar for duties.

Whereas, Medical Superintendent Govt. Super Specialty Hospital Srinagar vide no. SSH/2017/874 Dated. 16-08-2017 reported that Mr. Nath Pal Singh, Jr. Pharmacist was unauthorizedly absent from his legitimate duties w.e.f. 01-03-2017; and

Whereas, the concerned Medical Superintendent served the official two notices vide Nos. Est-I/SSH/86-89 dated. 17-04-2017 and Est-I/SSH/404-07 dated. 05-06-2017 whereby he was directed to report back to duties within seven days but the official failed to resume his

Whereas, after a considerable passage of time of more than six (06) years, the official sent his joining report to the office of Principal/Dean Govt. Medical College Srinagar on

Whereas, the matter was taken up with the Administrative Department vide this office communication no. AH/Est-IV/2024/8902 dated. 13-03-2024 for necessary directions/ instructions in the matter; and

Whereas, the Administrative Department (Health & Medical Education) vide their letter No. ME-NG/168/2024-02(E-7442887) dated. 02-04-2024 directed this office to proceed further in the case in terms of Article 128 and 113 of JKCSR; and


Whereas, after receipt of above directions from the Administrative Department, this office served the official with two (02) show cause notices vide No. AH/EST-II/2024/653-58 dated. 03-05-2024 and No. AH/EST-II/2024/653-58 dated. 03-05-2024, whereby the official was given ample opportunities to show cause as to why his services as Jr. Pharmacist shall not be terminated from the date of his unauthorized absence; and

Whereas, the official failed to report physically and instead sent his reply to the notice through his father which was found to be unsatisfactory; and

Whereas, it came to the notice of this office that the official has taken up an assignment in a private institution in Srinagar; and

Whereas, this office approached Director Tyndall-Biscoe and Mallinson Society Srinagar vide no. AH/MCS/Est-II/2024/2335 dated. 19-07-2024 to confirm the employment

Whereas, in response, Principal Tyndall-Biscoe and Mallinson Society Srinagar vide their office letter no. HR/HRM/1315/2024/TBMS dated. 13-08-2024, intimated this office that the official is working in their Institution as Lecturer w.e.f 25<sup>th</sup>, March 2017; and



Whereas, in terms of J&K Govt. Employees (conduct) Rules 1971, "No Govt. official whether on leave or active service shall, except with the previous sanction of Govt., engage directly or indirectly in any trade or business or undertake any other employment"; and

Whereas, continuous absence from duties by a Govt. Servant attracts action and tantamount to loss of service as warranted in terms of the Articles 113 and 128 of JKCSR (Volume-I) which read as under as:

## Article 128

"Absence without leave or after the end of leave involves loss of appointment".

## Article 113

"After five years of continuous absence on leave an officer is considered to be out of state employee".

Now, therefore, in view of the above facts and as recommended by Administrative Department, the appointment/service of Mr. Nath Pal Singh, Jr. Pharmacist (absentee) is hereby terminated from Govt. Medical College and its Associated Hospitals Srinagar from the date he has remained un-authorizedly absent from his legitimate duties i.e. 01-03-2017, in terms of the Articles 113 and 128 of Jammu and Kashmir Civil Services Regulations, 1956.
