The appointee shall report to the office of Principal/Dean Govt. Medical College Srinagar within a period of 21 days from the date of issuance of this order, failing which he shall forego his right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of following certificates in original to be verified subsequently:

- a. Date of Birth Certificate.
- b. Qualification Certificate.
- c. Domicile Certificate.
- d. Medical Fitness Certificate from Chief Medical Officer (CMO) concerned.
- e. No Objection Certificate from District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District. If the candidate has taken loan for self employment from DIC/Employment Department, he shall relinquish the proprietorship of Unit/Enterprise and also stakes if any in such self employment unit/enterprise before joining the Government Service. He shall be required to repay the entire liability in suitable EMI's to be worked out by the DDO concerned from his salary, DDO concerned shall obtain an affidavit concerned appointee regarding both relinquishment Proprietorship and stakes, if any, in such self employment unit Enterprise and recovery to be made and also personally monitor its recovery.
- f. Relevant category certificate, wherever applicable.
- g. Any other document as required under rules.

The salary of the appointee shall not be drawn and disbursed to him unless and until, satisfactory reports in respect of genuineness of qualification/Date of Birth/relevant category (if any) are received from the concerned authorities/agency.

The appointment of the candidate shall be governed by the New Pension Scheme as notified vide SRO-400 dated: 24-12-2009

The appointee shall be on probation for a period of two years.
