- ❖ That the Principals of concerned AMT / ANMT Schools Government / Private concerned while submitting the examination forms will examine and certify the eligibility of the candidates in respect of age, qualification, Registration etc. of the candidate as required as per norms.
- ❖ Internal assessment of Marks should be sent with the examination Forms along with other particulars such as Name, Parentage, Address, of each student in a pen-drive and one Hard Copy duly signed by the concerned Principal / Head of the Institution.
- ❖ That the concerned head of the institution should submit the certificate in favour of the Examinees that they have completed / undergone the clinical training for the Particular class which He / She is going to appear.

- ❖ That the Head of the concerned Institution will enclose a certificate to the effect that the examinee has got not less than 80% of attendance(Both Theory and Practical's).
- ❖ The Date sheet for the examination will be notified separately.

## **Eligibility Criteria:-**

- 1. Fresh / Regular Candidate(s) (BOPEE Batch-2020-2021 & 2021\_2022) and Backlog Failure Candidates are eligible for the said examination.
- 2. Failure / absent / Unfair means Candidates declared from the examination Session 2021-2022 for which the Results shall be declared for the pending examination are eligible from both Jammu & Kashmir Divisions.
