NOTIFICATION

In pursuance of S.O 333 of 2024, Dated: 13-06-2024 followed by Standard Operating Procedure(SOP's) issued by Administrative Department of Health and Medical Education Vide No: 378 - JK(HME) of 2024, Dated: 13-06-2024, , it is hereby notified for the information of all Government and Private Institutions of the Union Territory of Jammu and Kashmir that they shall invite the applications from eligible and desirous candidates for admission to left over seats for the courses which come under the recognized categories as per the schedule of National Commission for Allied and Healthcare Professions Act, 2021 of the session 2025-26.

The following terms and conditions shall govern the admission process:

1. Eligibility Criteria:

The concerned institutions shall strictly adhere to the eligibility criteria prescribed for admission to the respective courses, as determined by the Government Health and Medical Education Department and as notified by the J&K Board of Professional Entrance Examination (JKBOPEE) on its official website for the session 2025–26.

2. Merit Formulation:

After inviting applications for admission in the courses as stated above, the institutions shall prepare a merit list strictly based on the aggregate marks obtained in the $10+2(12^{TH})$ with PCB examination.

3. Admission Deadline:

The last date for admission against the leftover seats shall be 10-11-2025. All institutions are required to conclude the admission well before the prescribed cut-off date.

4. Verification and Validation of Credentials:

Upon completion of the admission process, institutions shall forward the list of shortlisted candidates admitted against leftover seats to the State Allied and Healthcare Council, J&K for verification of their eligibility. In the case any candidate is subsequently found ineligible, his/her admission shall be deemed null and void ab-initio.

5. Registration and Verification Schedule:

The schedule for registration and verification of credentials of the candidates by the State Allied and Healthcare Council, J&K shall be notified separately through an official communiqué in due course of time.

6. Domicile of J&K

Only domicile of UT of Jammu and Kashmir be admitted against the seats.

NOTE: -

- 1. The Institutions shall invite the applications for admission against left over seats for the courses coming under the purview of State Allied and Healthcare Council J&K and while doing so due care must be taken to give it wide publicity in print / electronic media and through institutions website.
- 2. After due advertisement of selection list by the concerned institutions, the candidates provisionally selected shall report for admission to the concerned institutions by or before 10/11/2025 (upto 5PM) along with their relevant certificates in original. The concerned heads of the institutes shall complete the admission process after the eligibility of candidates and verifying the following documents: -
 - (a) Domicile Certificate
 - (b) 12th Marks Card 10th Marks Card.
 - (c) Valid Category Certificate, If any.
 - (d) Date of Birth Certificate.
 - (e) Any other certificate required by the college in accordance with the rules.
- 3. Incase Candidates conceal/surpass any_ information at the time of admission. his/her candidature shall be cancelled ab-initio.
- 4. The Institutions upon finalizing the selection list shall take due care in allocating the reserved category seats as per relevant rules.
- 5. The Institutions shall submit the hardcopy of the selection list in the Office of State Allied and Healthcare Council J&K by or before 14/11/2025 5PM and softcopy via official e-mail.

6. The other terms and conditions shall remain the same as notified in the information
