Whereas, Mr. Rakesh Kumar, Laboratory Technician Level-6 (35400-112400) of this Institution had applied for the post of Sr. Laboratory Assistant/Jr. Laboratory Technician, in response to J&K Service Selection Board Advertisement no. 02 of 2021 dated. 26-03-2021 through proper channel and his application form was forwarded to the J&KSSB vide this office letter no. AH/Est-I/2021/1382 dated. 27-05-2021; and

Whereas, the official has been appointed as Sr. Laboratory Assistant in the pay level-4 (25500-81100) in Govt. Medical College Jammu vide order no. 262/AHJ/2024 dated. 02-09-2024; and

Whereas, upon the appointment of the official as Sr. Laboratory Assistant in the pay level-4 (25500-81100) at Govt. Medical College Jammu, he has tendered technical resignation and has requested for keeping his lien intact in this Institution for the period of two years (probation period at GMC Jammu); and

Whereas, the official has submitted an undertaking in the shape of an affidavit duly attested by First Class Magistrate affirming therein that he will not claim the benefit of lien beyond two (02) years from the date of tendering resignation as admissible under rules; and

Whereas, as per the Article-201 of J&K CSR Vol-I, "Resignation of an appointment to take up another appointment in which service counts, is not to be held to be a resignation of the Govt. Service, provided the consent of the former departmental superior is obtained to accept, such employment."

Now therefore, the technical resignation tendered by Mr. Rakesh Kumar, Laboratory Technician, Govt. Medical College Srinagar is hereby accepted w.e.f. 18-09-2024 (A.N) on his own request and is relieved from this Institution to take up his new appointment as Sr. Laboratory Assistant Pay Level-4 (25500-81100) in Govt.
