Applications on the prescribed format are invited from the (in-service/ not Inservice doctors) eligible candidates for the post of Registrar/Demonstrator on (tenure basis) in the following disciplines. However, the services of not Inservice doctors shall be hired on Academic Arrangement basis under S.O. 364 of 2020 Dated. 27-11-2020 and the in-service candidates shall be governed by the relevant rules as envisaged in the J&K Civil Service Rules 1979, initially for a period of one year extendable upto 03 years subject to better performance of the candidate during their 1<sup>st</sup> and 2<sup>nd</sup> years of engagement, which can be obtained from the respective HODs after completion of 1<sup>st</sup> and 2<sup>nd</sup> year of Registrarship/ Demonstratorship, as the case may be: -

12.	Pediatric Neurology	M.D. Paediatrics from a teaching Institution duly recognized by the Medical Council of India. DM/DNB Paediatric Neurology shall be given preference.
13.	Gastroenterology	MD Medicine from an institution duly recognized by the Medical Council of India. DM/DNB in the concerned discipline
14.	Neurology	MD Medicine from an institution duly recognized by the NMC. DM Neurology/DNB Neurology shall be given preference.
15.	Cardiology	MD Medicine from an Institution duly recognized by the NMC. DM Cardiology/DNB Cardiology shall be given preference.
16.	Endocrinology	MD Medicine from an Institution duly recognized by the NMC. DM Endocrinology /DNB Endocrinology shall be given preference.
17.	Neurosurgery	MS Surgery from an institution duly recognized by the NMC. M.Ch Neurosurgery / DNB Neurosurgery shall be given preference.

Candidates interested in applying for Registrar/Demonstrators posts at Government Medical College, Srinagar should download the respective application form from Government Medical College, Srinagar Website <http://www.gmcs.edu.in/> between 18-10-2022 to 15-11-2022 or the same may be collected from the Photostat Section of Government Medical College, Srinagar. The application forms should be accompanied with a non-refundable bank receipt of ₹500/- (**Rupees Five Hundred**) only from J&K Bank, GMC, Srinagar (account No. **0349040100007655**). Application forms complete in all respects should reach the office of the Registrar Academics upto 15-11-2022.

**Terms & Conditions: -**

1. Incomplete application form(s) in any respect or not attached with relevant certificates shall be rejected without further communications.
2. Conditions for Inservice/ Not in Service Candidates: -

**For in-service candidates:-**

- The In-service doctor shall be paid salary as per their LPC.
- Applicants working in Health and Medical Education Department are required to submit their application forms along with No Objection Certificate from their parent Department without which their application forms shall not be entertained as envisaged in Government Order No. 164-HME of 2012 Dated. 02.03.2012.

- Those in-service doctors who have already completed their tenure as Registrar/Demonstrator in any discipline need not to apply and their application forms shall not be considered.

**For not In Service candidates:-**

- Not Inservice doctors shall be paid stipend as per under S.O. 364 of 2020 Dated. 27-11-2020.

3. The application forms should be accompanied with the following self attested copies of the documents: -

- k. MBBS/Diploma/MD/MS/DNB/MCh./DM all terms marks sheet and qualification certificates of the respective specialty.
- l. Internship certificate.
- m. NMC/Jammu and Kashmir Medical Council Registration Certificate
- n. Physical active field service certificate after PG/Rural service prior to PG certificate issued by the Director, Health Services, Jammu/Kashmir in respect of in-service doctors.
- o. Attempt certificate 1<sup>st</sup>, 2<sup>nd</sup>, pre-final and Final MBBS examinations issued by the University of Kashmir concerned.
- p. Distinction/National Scholarship/Honors/Medals/Academic Merit certificates.
- q. House Officer (House job) experience certificate issued by the Principal concerned or equivalent recognized authority.
- r. Diploma certificate/postgraduate degree certificate.
- s. Date of Birth Certificate
- t. Professional publications in a standard medical journal, if any.

4. The candidates must produce an Affidavit duly attested by the Judicial Magistrate declaring that: -

- the applicant has not done Registrar-ship/Sr. Residency earlier within or outside J&K Union Territory (only for Inservice candidates).
- he/she is a Not In Service candidate (the information if found wrong he/she shall be punished under Rules) (only for not Inservice candidates).

5. The selected candidate has to submit an affidavit to the effect that he/she is not on the rolls of any Medical Colleges/Institutions of the country which is pre-requisite in terms of NMC norms.

6. Maximum age for eligibility to apply shall be 50 years as on 01-10-2022

7. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.

8. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
9. Separate application form is to be filled for each post and fee is to be deposited separately for each post, applied for.
10. In case of any declaration by the candidate is found false or if the candidate has willfully suppressed any material/information relevant to his/her appointment, his/her selection will be cancelled ab-intio liable for action as Warranted under rules.
11. Candidates meeting the eligibility criteria and producing all the prescribed documents will be interviewed.
12. The selected candidates shall have to execute an agreement that he/she will not leave the Department before the completion of Registrarship/ Demonstratorship term, however abandoning/terminating of the arrangement in the Specialty will require one month prior notice on either side failing which the salary shall not be paid for one month to the incumbent which shall always remain in deposit with the Department and shall be released on completion of sanctioned term.

The selection of the candidates will be made on the basis of combined academic merit and performance at the interview.
