Subject:-Final Seniority list of Medical Record Unit of Government Medical College and Its Associated Hospitals Srinagar as stood on 01-10-2024.

Whereas, vide notification No. GMCS-HS-171/3040-51 dated 16-08-2024, a tentative seniority list of the Medical Record Unit of Govt. Medical College and its Associated Hospitals Srinagar was notified for information of all the members of the concerned unit for inviting objections, if any, within a period of (21) twenty one days, and

Whereas, various representations from the members of the unit were received through their respective controlling officers, wherein the following issues have been raised:-

- (a) Medical Superintendent Govt. SMHS Hospital Srinagar vide communication No. PA/MS/SMHS/3938 dated 21-08-2024 has forwarded a joint representation of Mr. Mushtaq Ahmad Lone and Mr. Nisar Ahmad Lone, Medical Record Supervisors wherein the officials have stated that they belong to RBA category which has not been mentioned in the tentative seniority list against their names and have requested for reflection of RBA category on the support of certificates/documents produced by them.
- (b) Another communication received from Dy. Registrar Academics vide No. GMC/ Acad/3942/MC dated 22-08-2024 wherein he has forwarded the application of Mr. Rizwan Hamid, Medical Record Technician stating therein that:-
 - I. The official belongs to OBC (Najar) category as per the certificate issued by Tehsildar Yaripora Kulgam vide No. JK-Rev-SEB/2024/29973 dated 27-05-2024, however, the same has not been reflected in the tentative seniority list against his name.
 - II. His name should figure at serial No. 05 in the tentative seniority list instead of 07 due to the reasons that in terms of Govt. order No. 17 JKHME of 2023 dated 04-01-2023, the study leave period of 06 months of his senior fellows namely Mr. Shahnawaz Ahmad Najar and Mr. Aadil Ahmad Bhat figuring at serial No. 05 and 06 has been treated as dies-non, but the period has not been imported while framing the seniority of the concerned category.
- (c) Another communication received from Medical Superintendent Govt. Children Hospital Srinagar vide communication No. 1860 dated 04-10-2024 where under he has endorsed the communication of Medical Superintendent Bone and Joint Hospital bearing No. 2997 dated 17-09-2024 along with representation and other documents submitted by Mr. Muneer Ahmad Wani, Sr. Medical Record Technician wherein the official has stated that he belongs to RBA category which has not been mentioned in the tentative seniority list against his name and has requested for reflection of RBA category on the support of certificate produced by him.

Whereas, the above issues were examined with reference to relevant records and the representations have been redressed as follows:-

- (a) That on examination of the documents viz. initial appointment order issued by the department vide order No. 797 of 2015 dated 25-02-2015 and the certificates issued by the concerned Tehsildar (Pulwama) vide No. 345/MM/Pul dated 23-12-2010 and 109/MM/Pul dated 08-05-2010 reflects and certifies the officials as "Residents of Backwards Areas".
- (b) I. That, as certified by Tehsildar Yaripora Kulgam vide No. JK-Rev-SEB/2024/29973 dated 27-05-2024 the official has been shown as a member of "Socially and Educationally Backward Class-OBC".

II. That among others, the officials were initially deputed for undergoing 6 months MRT Training from Safderjund Hospital New Delhi as departmental in-service candidates vide order No. 195, 196 and 197 dated even and their cases for study leave were forwarded to the Administrative Department for grant of necessary sanction vide letter No's 1631-32 dated 29-06-2018 and 1633-34 dated 29-06-2018. The necessary sanction as post facto study leave for pursuing 6 months course was sanctioned in favour of Abrar Zahoor, Rizwan Hamid and Gousia vide Govt. order No. 79 HME of 2019 dated 18-01-2019 leaving other two candidates as such and the study leave period in their respect was treated as Dies-Non vide Govt. order No. 17 JKHME of 2023 dated 04-01-2023. The same treatment was challenged by the aggrieved officials through Hon'ble Central Administrative Tribunal at Srinagar vide O.A No. 44/2023 titled Aadil Ahmad Bhat Vs Health and Medical Education department and others and was ordered to be put on abeyance vide order dated 01-02-2023 which is still sub-judice. In view of the directions of Hon'ble CAT dated 01-02-2023 the claim of the official (Mr. Rizwan Hamid) for importing the period of dies Non in respect of 05 and 06 without disposal and final decision of the case by the Hon'ble Court of Law (CAT) cannot be considered at this time in anticipation of final decision of the CAT in this regard.

(c) That on examination of the category certificate issued by Tehsildar (Khanshabib) vide No. MM/HK/322 dated 20-06-2013 certifies the candidate as "Residents of Backwards Areas".

Now, therefore, the Final seniority list of the Medical Record unit is hereby circulated as "**Annexure-A**" for information of all the members of the concerned unit. The Controlling Officer(s) will furnish a copy of Final Seniority List to each official(s) on his/her establishment(s). The same will be available on our official website www.gmcs.edu.in.
