Whereas, You were engaged as senior Resident vide this Office Order No. 188-RA of 2022 Dated. 17.05.2022 as an in-service candidate for undergoing tenure posting/training course on deputation to this college in the department of Radiotherapy for a period of one-year, extendable upto three years, on the basis of good performance to be certified by concerned HOD; and

Whereas, you were allowed to join as Senior Resident in the department of Radiotherapy w.e.f. 20.06.2022 after getting properly relieved from Govt. Medical College, Rajouri and in compliance to Govt. Order No. 400-JK(HME) of 2022 Dated. 14.06.2022; and

Whereas, before joining the department, you had furnished an affidavit that you shall remain disciplined during the tenure of Senior Residency and any kind of misconduct shall make you liable for termination without any prior notice; and

Whereas, you had proceeded on (30) days Earned leave w.e.f. 19.08.2024 to 17.09.2024 sanctioned by this office vide Order No. 480-RA of 2024 Dated. 13.08.2024; and

Whereas, you were supposed to resume your legitimate duties on 18.09.2024 after availing (30) days earned leave sanctioned in your favour but you have submitted casual leave for a period of (09) days w.e.f. 18.09.2024 to 26.09.2024 and even after expiry of the same you did not resume your duties; and




Whereas, this office has received your application duly endorsed by concerned HOD Vide No. HOD/RO/MC/348 Dated. 05.10.2024, wherein, it has been distinctly indicated that due to some personal reasons, you are not able to continue Registrarship in the said department and requested to relieve you back to your parent department viz., Directorate of Health Services, Jammu; and

Whereas, you have not resumed your legitimate duties w.e.f. 18.09.2024 till date and have preferred to remain on unauthorized absence from your legitimate duties, which has created lot of indiscipline in the department; and

Whereas, you have breached the conditions as laid down in the order(s) and such type of practice is highly objectionable and is total violation of the standing Rules, as it has direct impact on patient care services.

Now, therefore, you are hereby directed to explain your position within a period of (05) days from the date of issuance of this notice. Your explanation should reach this office through the concerned HOD alongwith his definite remarks within the stipulated time, failing which, it shall be presumed that you have nothing to say in your defense and disciplinary action shall be initiated against you.
