1. The selected candidates are supposed to submit their joining report alongwith an affidavit(s) in the office of the undersigned duly attested by the Judicial Magistrate to the effect that: -
  - a. They will not participate in any kind of strike during the period of their tenure engagement. In the event they proceed on strike, their tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.



- b. They shall remain disciplined during the whole tenure; any kind of misconduct shall make them liable for termination without any prior notice.
  - c. They are not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against them.
  - d. They shall not claim any experience certificate, in case, they leave Senior Residency before completion at least of six months
  - e. They will not indulge in any private practice. In case, they are found doing private practice their appointment shall be liable for termination without any notice.
2. The appointees are required to join within (21) days from the date of issuance of this order failing which the order shall be deemed to have been cancelled.
