Grade (OPG) purely on Stop Gap Arrangement.

Pending clearance by the Departmental Promotion Committee (DPC), without prejudice to the seniority of others and as recommended by the Establishment Committee held on 14-10-2025, sanction is hereby accorded to the placement in favour of the **Mr. Tajamul Islam**, Sr. Pharmacist working in the substantive Pay Level-6 (35900-113500) as **I/c Supervisory Pharmacist**, in his own pay and grade purely on Stop gap Arrangement basis for a period of six months or till the post is filled-up on regular basis on the recommendations of Departmental Promotion committee, whichever is earlier, against the available vacancy of Supervisory Pharmacist on the establishment of Medical Superintendent, Govt. Lalla Ded Hospital Srinagar.

The placement is subject to the following terms and conditions, that:

- 1. The above placement is temporary and shall not confer any preferential right on the official to hold the post on substantive basis or claim promotion which shall be made in accordance with the rules.
- 2. The above placement is purely on Stop Gap Arrangement Basis for a period of six months or till the post is filled up by the competent authority/DPC whichever is earlier.
- 3. The above placement is subject to the final outcome of the writ petition(s) pending before Hon'ble Court of Competent Jurisdiction or any order already passed in this regard and not in the immediate notice of Establishment Committee.
- 4. The concerned DDO shall ensure that the official is not under suspension or involved in embezzlement/criminal case, etc.
- 5. The placement is also subject to final outcome of departmental proceedings, if any, pending against any official.
- 6. The above placement is further subject to the clearance and acceptance of the service details/records submitted in the prescribed J&K Human Resource Management System (HRMS) portal.
 - The concerned DDO shall ensure that appointment of the official is genuine and the appointment order in respect of the promotee have been issued by the competent authority in terms of the norms issued by Government from time to time before recording necessary promotion entries in the service records of the official.
- 8. The claim of the senior(s), if any, received within the stipulated time, shall be evaluated as per governing norms and if found necessary, the senior incumbent

shall be placed in OPG/ promoted at proper place by demoting the junior most one(s), ab-initio without giving any notice.

- The official shall continue to work at his present place of posting till further 9.
- The placement made as I/c Supervisory Pharmacist shall not confer upon the official any preference with regard to the monetary benefits, which shall be decided by the ensuing DPC as and when convened strictly in terms of rules/
