WHEREAS; on the basis of recommendations made by the Selection Committee constituted vide Order No. 05-GS of 2024 Dated. 06-01-2024, **Ms. Jurhaira Rashid D/O. Abdul Rashid Lone R/O. Rehmatullah Colony Mujgund, Srinagar** was engaged as **Infection Control Nurse** on contract basis on monthly remuneration in the Department Microbiology Govt. Medical College, Srinagar under National Programme on Antimicrobial Resistance Containment vide this Office Order No. 329-GS of 2024 Dated. 15-10-2024 with the directions to report Head of the Department of Microbiology Government Medical College Srinagar for further duties within a period of (21) days from the issuance of engagement order;

WHEREAS; in the above referred engagement order it was clearly mentioned that if she fails to join her engagement within a period of (21) days, her engagement shall be cancelled without any further notice;


WHEREAS; the Head of the Department of Microbiology vide her letter No. HOD/Micro/2024/870 Dated. 14-11-2024 has reported that **Ms. Jurhaira Rashid** failed to join her duties within a stipulated time;

WHEREAS, this Office and Nodal Officer of the project made several attempts to contact her on phone but she did not pickup the phone;

WHEREAS; despite lapse of further (20) days she has not reported Government Medical College, Srinagar for duties which clearly indicates that she is not willing to take up the said assignment and;

WHEREAS; this Department is left with no choice but to cancel the engagement of **Ms. Jurhaira Rashid** and make alternate arrangements;

Now, therefore, keeping in view the above facts, the engagement of **Ms. Jurhaira Rashid D/O. Abdul Rashid Lone R/O. Rehmatullah Colony Mujgund, Srinagar** as **Infection Control Nurse** on contract basis on monthly remuneration in the Department Microbiology Govt.
