Terms and Conditions

- The candidates shall report to the office of the Principal/Dean, Govt. Medical College Srinagar for joining within a period of twenty one (21) days, from the date of issuance of this order, failing which their engagement as such shall stand cancelled without any further notice.
- 2) The arrangements shall be purely on temporary basis and the candidates shall have no right to claim for their appointment against the said posts on regular basis on the basis of this temporary arrangement as and when the same are filled by the competent authority under rules/norms.
- 3) The candidates shall have to execute an agreement with the Government on the prescribed form in terms of S.O 364 of 2020 Dated: 27-11-2020. The engagement shall be for a period of one year or till the posts are filled up on regular basis on the recommendations of Jammu and Kashmir, Services Selection Board, whichever is earlier.
- 4) The arrangement shall be regulated under other terms and conditions as specified in S.O. 364 Dated: 27-11-2020. The engagement so made on academic arrangement basis is for one year only from the date of engagement and shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections/promotions are made in accordance with the recruitment rules governing the posts, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.
- 5) The salary in favour of the engaged candidates shall not be released unless a satisfactory report is received from the Criminal Investigation Department, J&K.
- 6) The salary in favor of the incumbent shall not be drawn and disbursed unless and until, satisfactory reports in respect of genuineness of Qualification certificate/Date of Birth certificate/Domicile certificate/Relevant category certificate (if any), is received from the concerned authorities/agency.
- 7) The engagement of the appointee shall be governed by the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O 364 of 2020 Dated: 27-11-2020.

8) The engagement shall be subject to the outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
