Terms and Conditions

- 1) The Drawing and Disbursing Officer(s)/Controlling officer(s) are hereby asked to ensure fulfillment of all the terms and conditions as laid down in their engagement order issued by the Govt. vide No. 858-JK (HME) of 2024 Dated: 10-12-2024.
- 2) The Drawing and Disbursing Officer(s)/Controlling officer(s) shall ensure the verification of all the documents as mentioned in the notice issued vide No. GMC-Sgr/AH-9/Est-IV/2024/4630-33 dated:- 10 -12-2024.
- 3) The salary in favor of the incumbent shall not be drawn and disbursed unless and until, satisfactory reports in respect of genuineness of Qualification certificate/Date of Birth certificate/Domicile certificate/Relevant category certificate (if any), is received from the concerned authorities/agency.
- 4) The engagement of the appointee shall be governed by the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O 364 of 2020 Dated: 27-11-2020.
- 5) The engagement of the appointee shall be subject to outcome of writ petition(s), if any, pending on the subject in any court of competent jurisdiction.
- The appointee shall give an undertaking in the shape of an affidavit duly attested by 1st Class Judicial Magistrate to the effect that if on verification, his Qualification/Date of Birth/Reserved category certificate from the concerned issuing authorities are found fake/forged, his/her engagement as "Medical Officer on Academic Arrangement Basis" in Govt. Medical College & Its Associated Hospitals Srinagar shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her. In that case, he/she will not claim for any dues from the Govt. Medical College Srinagar (Already submitted by the incumbents with the office of the undersigned).
- 7) The arrangements shall be purely on temporary basis and shall not confer upon the candidates any special claim/right for their appointment against the said posts on regular basis as and when the same are filled under rules.
- 8) The candidates shall have to execute an agreement with the Government on the prescribed form in terms of S.O 364 of 2020 Dated: 27-11-2020. The engagement shall be for a period of one year or till the posts are filled up on regular basis on the recommendations of Jammu and Kashmir, Public Service Commission, whichever is earlier (Already executed by the incumbents with the office of the undersigned).
- 9) The arrangement shall be regulated under other terms and conditions as specified in S.O. 364 Dated: 27-11-2020. The engagement so made on academic arrangement basis is for one year only from the date of engagement and shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections/promotions are made in accordance with the rules of recruitment governing the posts,
