- 3. The engagement is purely on contract basis for a period of one year.
- 4. This contractual engagement is not being made against any substantive post and as such will not in any cases(s) confer any right upon the incumbents to claim

regular appointment, seek extension when the scheme gets over/funds get exhausted.

5. The contractual term of one year is terminable even before the term expires without any notice/citing any reason in case the performance is not satisfactory.

6. The engagement will be for a period of one year or till the continuation of the scheme, whichever is earlier and will be extended further with break of one to two days subject to the satisfactory performance of the incumbents/approval of the competent authority and:

a. Availability of budget.

b. Continuation of the scheme.

7. The engaged candidate(s) shall have to execute an agreement that he/she shall not leave the department before the completion of one year contract. However, abandoning/termination of the engagement under the scheme will require one month's prior notice on either side, failing which the remuneration shall not be paid for one month to the incumbent which shall always remain in deposit with the department and shall be released on completion of sanctioned term.

8. The incumbents shall have to work as per the job assigned under the above

referred project/scheme.

9. If the incumbents at any point of time willfully neglect or refuse to perform the assigned duties, his/her engagement shall be terminated forthwith without any notice and shall not be entitled to any salary/remuneration for such period.

10. The incumbents shall also submit an undertaking in the shape of an affidavit duly

attested by the 1st class judicial magistrate to the effect:

i. That in case an adverse report about the qualification, DOB, Marks Certificates, Domicile Certificate etc. if any, is received from the competent authority to whom the reference shall be made by this office, the candidate shall have no right to claim for engagement as above and engagement as such shall be deemed to have been canceled ab-initio. The candidate shall not also claim any dues from Govt. Medical College Srinagar as well in that case and next candidate as per the merit shall be considered for engagement.

ii. That the candidate has fully understood the terms, conditions and nature of engagement in Govt. Medical College Srinagar as per the guidelines/norms of the Ministry of Science & Technology, Department of Biotechnology GoI, and will not claim for regularization after completion of the term or at any point of

time/seek extension when the scheme gets over/funds get exhausted.

The incumbents shall personally report to the office of the Principal/Dean, GMC Srinagar for submission of the necessary inputs/documents for processing verification of their Character and Antecedents through online mode from Criminal Investigation Department (CID) as per Government Order No:- 528-JK(GAD) of 2021 Dated 21-06-2021 and Govt. Order No:- 1003-JK(GAD) of 2021 dated 27-09-2021 issued by General Administrative Department J&K.
