The placement is subject to the following terms and conditions, that:

1. The above placement is temporary and shall not confer any preferential right on the officials to hold the posts on substantive basis or claim promotion which shall be made in accordance with the rules by the competent forum i.e. DPC.
2. The above placement is purely on Stop Gap Arrangement Basis for a period of six months or till the posts are filled up by the competent authority/DPC whichever is earlier.
3. The above placement is subject to the final outcome of the writ petition(s) pending before Hon'ble Court of Competent Jurisdiction or any order already passed in this regard and not in the immediate notice of Establishment Committee.
4. The concerned DDOs shall ensure that the official is neither under suspension nor involved in embezzlement/criminal case, etc.
5. The placement is also subject to final outcome of departmental proceedings, if any, pending against any official.
6. The above placement is further subject to the clearance and acceptance of the service details/records submitted in the prescribed J&K Human Resource Management System (HRMS) portal.
7. The concerned DDOs shall ensure that appointment of the official is genuine and the appointment orders in respect of the promotee has been issued by the competent authority in terms of the instructions issued by the Government from time to time before recording necessary placement entries in the service records of the official(s).
8. The claim of the senior(s) if any received within the stipulated time, shall be evaluated as per governing norms and if found necessary, the senior incumbent(s) shall be placed on OPG/promoted at proper place by demoting the junior most one(s), ab-initio without giving any notice.
